Let's Support Ag Education in Maryland by Supporting SENATE BILL 770

Maryland Farm Bureau and Howard County Farm Bureau both support this bill. As one of the three counties in Maryland with no agricultural education, (Somerset and Alleghany are the other two) we can join with Howard Soil Conservation Districts, Howard County Economic Development Authority, Maryland Ag Education Foundation and others to take action now to show our support.

The bill, SB770, "Education – Public High Schools- Agriculture Science", requires each county board of education, beginning in the 2018-2019 school year, to implement an Ag science curriculum in at least one public high school in each county or at least one career and technology education center using an approved curriculum. The bill is sponsored by Senator Bates (District 9, Carroll and Howard counties) and Senator Norman (District 35, Harford and Cecil counties). There is a hearing on February 24, 1:00 pm ET before the full Education, Health, and Environmental Affairs Committee. Senator Bates serves on this committee.

Maryland Farmers Attend National Convention in Orlando

Davidsonville, MD (January 15, 2016)—Maryland Farm Bureau (MFB) officers, members and staff attended the 2016 American Farm Bureau Federation (AFBF) Annual Convention in Orlando, FL from January 8-12. 6,000 Farm Bureau leaders from all 50 states collaborated to vote on national policy, elect a new President and Vice President, learn about new Ag trends and technologies, compete for Young Farmer & Rancher awards and celebrate agriculture in the U.S.

Maryland was well represented in the competitions at the AFBF convention. Michael Calkins of Howard County participated in the Young Farmers & Ranchers Discussion Meet competition. Michael and representatives from three other states discussed new technologies for producers and getting the public to support right-to-farm laws. Michael is a Soil Conservation Planner and Stormwater Management Specialist for the Howard Soil Conservation District. Along with his wife, Ali, they manage a horse riding and training business.

Jamie Tiralla of Calvert County participated in the Young Farmers & Ranchers Excellence in Agriculture competition. This honor is to recognize those Farm Bureau members who do not earn the majority of their income from farming. Jamie presented her application at the AFBF convention, focusing on her transition from suburban living to the farm and how she balances her career, family and farming. Jamie is the Creative Director for an advertising agency in Baltimore. She and her husband, Benson, live on a 115-acre farm with their two children, Caroline and Henry. They raise grassfed beef, lamb and goat, as well as pork and sell their meats at a farmers market.

Jeremiah and Janelle Weddle of Washington County participated in the Young Farmers & Ranchers

Achievement competition. This honor is presented to one Farm Bureau member from each state who earns the majority of their income from farming. They attended the AFBF convention to represent Maryland in the Achievement category. The couple co-owns and operates Creek Bound Farms, LLC and produce corn, soybeans, wheat, alfalfa and small grain forages on the 2,500 acre farm. They also raise 350 replacement heifers.

After sixteen dedicated years of service as President of the American Farm Bureau Federation, Bob Stallman of Texas retired and Zippy Duvall of Georgia was elected as the new President during the final day of convention. Scott VanderWal of South Dakota was also elected as the new AFBF Vice President, taking the place of former VP Barry Bushue of Oregon.

"I am honored to begin serving alongside you all as the new president of the American Farm Bureau Federation," said Duvall. "For almost a century, AFBF has been the leading voice of agriculture, standing up for farmers and ranchers across our great country. But the real strength of Farm Bureau is our active grassroots membership. Like you, I learned a long time ago that I'd have to step outside my fencerows if I wanted to have a say in the matters affecting my farm. You are the backbone of the organization, and together we can address the toughest issues facing U.S. agriculture in 2016."

Maryland Farm Bureau is a private, non-profit membership organization. It is controlled by its members through the democratic process and is financed by voluntary membership dues. Its strength comes from the active participation of over 36,000 member families that belong to the state's 23 county Farm Bureaus. For the last 100 years, Maryland Farm Bureau has served to promote and protect Maryland agriculture and rural life.

Ranching and Dairy Farming in Florida! - AFBF Convention Ag <u>Tours</u>

Typically when you think of Florida, the first thing that comes to mind as far as agriculture is oranges! And of course there is more to the state other than its sandy beaches, but large scale ranching and dairy farming comes as more of a surprise. This years American Farm Bureau Federation Annual Convention in Orlando offered almost a dozen agricultural tours by Florida Farm Bureau Federation. Some of the countries largest agricultural operations are located in Florida; and I don't just mean citrus groves or vegetable farms but also ranches raising beef cattle and dairies! Thank you to Howard Counties own Howie and Christina Feaga, and Zack and Kerry Brendel, for sharing your experiences on these Ag tours in Florida!

One of the tours visited Deseret Ranch; a 295,000 acre or 450 square mile, agricultural operation, stretching across Orange, Osceola, and Brevard counties. For over 60 years the land has been made commercially productive for beef cattle, citrus, and timber. From the beginning, the ranch has worked in cooperation with other local ranchers, government leaders, and academics from multiple universities to improve resource management and agricultural operations.

The Ranch's core business has been cattle ranching. Deseret maintains a herd of approximately 42,500 cows that produce 36,000 calves each year! The herd is divided into 14 management units and the average unit runs approximately 3,100 cows. At Deseret, a single cowboy typically manages about 1,200 cows. The cows on each unit are further divided into smaller herds, and each herd rotates among several pastures to promote pasture health and optimize cattle performance.

Along with a large cattle operation the key to success at Deseret is their sustainable management of resources, stewardship of wildlife, wetlands, and water resources.

Another Ag tour visited Davie Dairy, a 4,500-cow family-owned and operated dairy farm located in Okeechobee, Florida. The Dairy operates on 960 acres with several thousand additional acres where it raises heifers. The Dairy is operated by William Berman and Glynn Rutledge who are partners in the second-generation family-owned dairy business. The two have earned a reputation for ethical business practices, hands-on management, agricultural innovation and environmental stewardship, often partnering with State and Federal government agencies to participate in agricultural research and water management studies. William Berman currently serves as the President of United Feed Coop of Okeechobee, Florida. He is also a member of the board of Southeast Milk, the leading milk coop serving all of Florida and several Southern states.

Davie Dairy has stayed at the forefront of agriculture technology. It was the first dairy in South Florida to build and utilize free stall barns which has become the norm in South Florida today. They also later built an innovative "Maternity Barn" facility, creating better supervision of births which resulted in more live, healthy calves and reduced the incidence of Johnes' Disease. After over 50 years, Davie Dairy is run by William and Glynn along with a team of over 40 employees, several of whom are second-generation members of the Davie Dairy family.
